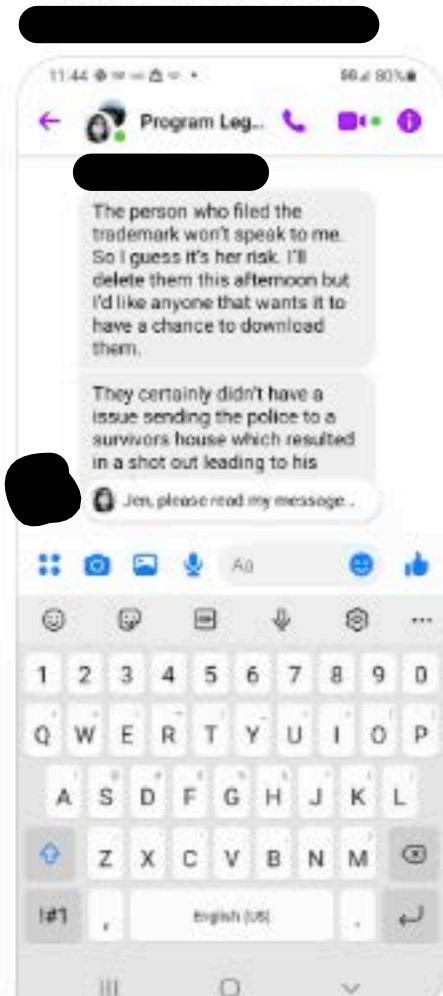

The culture of our community is broken. Things need to change. I have been targeted, had my family, friends contacted and suffered severe real life consequences from a false narrative put out by a certain survivor.

All I did was try to help. But now I'm going to law enforcement with everything. I'm done with this harassment and the slandering of my name.

This cycle needs to break and it has been going on a long time.



I don't care about the documents my issue was the statement along with it. It was clearly aimed at Katie, especially when you just admitted that you wanted to show how she refiled. Accusing any survivor of being ok with or quick to call the police on another survivor, especially in light of his resulting death, is just wrong. It has to stop.

However one thing I need to point out is that BCS just updated their rules to clearly state that they will call the police if they assume a survivor is suicidal. I believe this is an issue that does warrant conversation because I believe survivors need to have a safe space to vent without fearing the police will be called. Can you weigh in on how you feel about that policy? Because I believe that is where this paranoia is coming from. We know this has happened several times now... and that there have been real and life changing consequences. And I believe survivors need to consent to treatment and help if they ASK for it... not based on a comment that could be construed as suicidal.

In Texas we are all mandated reporters so I've had to remind people not to post certain things because people will report and you are right - we all need room to struggle . The people who look the happiest are often the ones hurting the most

You will lose your kids

So we need to be very very careful what is posted



And only report when we know someone is a legitimate risk to themselves or others

And I don't know what their official policy is about that. I'll look at it and see if what their process is in deciding when to call.

I just know as a mandatory reporter I had to report many things that were a bit vague.

And now recently, someone who had their Facebook hacked was institutionalized for something they did not post. I have seen concerning posts before as well, and what I did was call someone that knew that person to check on them, and they called their therapist to follow up. All was well, they were just down and venting. That's usually what's happening and we can't be trigger happy to abuse police authorities when there are better ways to help. Have a plan, have a step by step strategy to give support. And better yet, how about we actually create the services survivors need? That was our intention with BCS, to create a fund for survivors to access free professional mental health services. That's not what we got tho. The fact is, despite all the good that BCS has done to help survivors feel validated and safe to share their stories, reliving that trauma takes a toll on mental health and we needed support services a LONG time ago. This is what our community has been begging for, and what I will still dedicate myself to make happen.
