I respectfully request that you advise your clients to refrain from accusing me of being part of a "plot to sue" and remove both my name and my organization's name from their website. I had no involvement in the lawsuit against Katherine and Jeremy, nor did I have anything to do with an alleged de-indexing of the website to "frame" Katherine. I'm appalled that this is the outlandish theory you've concocted; moreover, it's a serious accusation of criminal behavior. The insinuations and baseless accusations of any alleged involvement in a "plot," based on an unrecoverable Slack channel and lacking any supporting evidence, are absolutely absurd.

I would even go so far as to show that you deliberately ignored actual evidence of what that Slack channel contained. As the attached email indicates, a document you have referred to as "evidence" actually begins with a reference to the FBI Guardian case.

When Katherine initially took control of our accounts, we reported the theft to the FBI. When she (allegedly) did the same to the BCS organization, we suggested they report it to the same agent. We had every right to report Katherine's actions to the FBI. Referring to this as a "plot to sue" is a deliberate and malicious misrepresentation.

If you recall, my entire reason for filing a motion to quash the subpoena was my concern that Katherine would use this information solely for harassment and defamation. The judge in the case even recommended that I obtain a restraining order if such misuse occurred. Furthermore, the fact that evidence of the Slack channel's actual content was disregarded is highly irresponsible and provides grounds to report you and your firm to the bar.

Obviously, we are all weary of litigation, and I would prefer to avoid further legal action. Given that you have received information disproving your unfounded allegations, I ask that you remedy this situation by advising your client to remove any mention of my name and false allegations of my involvement in a "plot to sue" from her website.

I have already requested that Katherine remove this false information, but she has refused. I urge you to press her to retract these malicious, false statements that are widely known to be untrue and have damaged my reputation and hindered my ability to pass background checks. This is the very definition of defamation. All references to my name and organization must be removed immediately.
